PRODUCT RETURN POLICY:

AT OUR ROASTING ESTABLISHMENT, WE ROAST 'ON DEMAND', MEANING THAT ONCE WE HAVE RECEIVED YOUR ORDER/S, WE THEN ROAST THE GREEN COFFEE BEANS (BLEND OR SINGLE ORIGIN) IN SMALL CONTINUOUS BATCHES IN OUR COFFEE DRUM ROASTING MACHINES, AND THEN WE PASS IT THROUGH OUR DESTONER EQUIPMENT TO REMOVE ANY FOREIGN MATTER THAT MAY BE PRESENT. THE COFFEE BEANS ARE THEN PACKED IN SUITABLE 'TRILAYER' SPECIALITY COFFEE PACKAGING WITH A 'ONE WAY RESLEASE VALVE', AND THEN IT IS BOXED AND LABELED AND THEN EARMARKED FOR SHIPPING/COURIER. OUR PREFERRED COURIER PARTNERS, COLLECTS DAILY AND THEN SHIPPED/COURIED TO THE CUSTOMER AS EFFIICIENTLY AS POSSIBLE, USUALLY WITHIN 2-4 WORKING DAYS DEPENDING ON THE CUSTOMER LOCATION. ROASTED COFFEE BEANS ARE SEEN AS A PERISHABLE PRODUCT, WITH A LIMITED SHELF LIFE AND SHOULD BE CONSUMED WITHIN AN 6 WEEK PERIOD. PLEASE NOTE THAT CORRECT COFFEE STORAGE, STOCK ROTATION AND MANAGING OF STOCK LEVELS MAY ALSO HAVE A SIGNIFICANT IMPACT ON THE CUP BREWING QUALITY. DUE TO THE COMPLEXITIES OF PRODUCT, INCLUDING SENSITIVITY TO HEAT, AND THE POTENTIAL IMPACT OF VARIOUS PERIPHERAL VARIABLES OUTSIDE OF OUR CONTROL, WE UNFORTUNATELY DO NOT ACCEPT RETURNS OF ROASTED COFFEE. IF YOU FEEL THAT YOU HAVE A LEGITIMATE QUALITY PROBLEM, PLEASE FEEL FREE TO CONTACT US AND WE WILL COMMIT TO ENGAGE WITH YOU TO RESOLVE THE MATTER AS EXPEDIENTLY AS POSSIBLE.

DOMESTIC SHIPPING POLICY:

ALL ORDERS ARE PROCESSED ACCORDING TO 'TIME OF RECEIPT' PROTOCOL AND IN 'CHRONOLOGICAL SEQUENCE' EMBRACING THE PRINCIPLE OF 'FIRST IN - FIRST OUT'.
